2021/2022 ACCOMPLISHMENTS

- Clean audit with absolutely no findings for the 20th consecutive year
- Maintained hotel agreements for emergency shelter provision
- Applied for and received additional COVID-19 relief funds to continue providing emergency shelter via hotel
- Two staff certified to provide the Mandated Reporter

 Training to community organizations
- Developed a screening and referral process with Columbia County Volunteers in Medicine
- Partnered with the Columbia/Montour Area Agency on Aging to provide a regularly occurring training program at local senior centers.
- Designated a private, safe place with the resources/supplies and equipment necessary for survivors and their children to safely access medical and mental health care utilizing telehealth services
- Established a Healthy Survivor Support Fund to support survivor's healthcare related needs, including COVID support bags, food, personal care items, cleaning supplies, and gift cards
- Met with FBI Victim Specialist Advocate to collaborate in regional service area
- Expanded DELTA prevention education programming to school districts throughout Columbia and Montour County

2021/2022 ACCOMPLISHMENTS


- Hosted a successful toy drive, collecting over 300 toys and raising almost \$500 for the purchase of toys for families in need
- Held our Annual Participant Holiday Event as a meal and toy pick up, serving over 40 meals to adults and children
- Participated in Bloomsburg University's internship program, hosting seven students.
- Continued our Healthy Workplace Initiatives through a second Healthy Workplace Grant.
- Conducted a DEI assessment of the organization and began implementation of DEI initiatives
- Began the process of developing a strategic plan for the next five years.
- Re-started in-person programs and services at NCSTU and the For the Cause Teen Center
- Provided 137 instances of emergency financial assistance (emergency food, cleaning supplies, and personal care items)
- Raised \$34,897 in total donations
- Expanded internal infrastructure and capabilities
- Maintained representation on local social/human service boards across Columbia and Montour County
- Partnered with the Columbia County Housing Authority to provide transitional housing to 2 woman and 3 children through our Bridge House Program
- Increased continuing education and skills development for all staff






